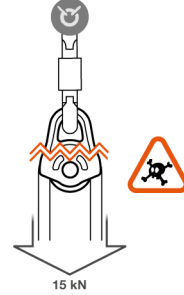

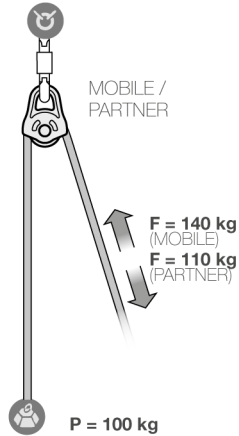


5B. Breaking load /

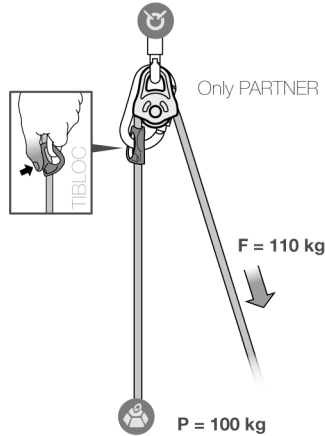

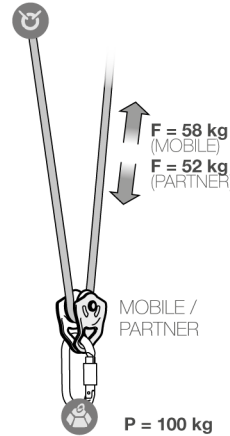
6A. Simple pulley system



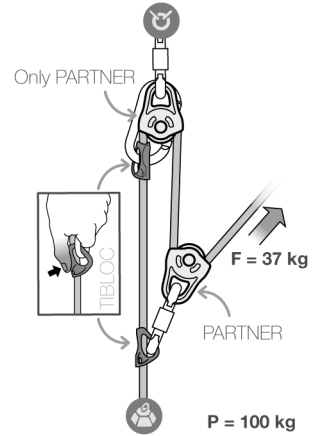

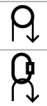
6B. 2:1 hauling system
